

**TOWN OF TOWNSEND**  
**ORDINANCE NO. 02 -, 2009**

**ORDINANCE REGULATING LAND DIVISION AROUND LAKES 30**  
**ACRES OR LESS**

**PURPOSE:** The Town of Townsend (the "Town") believes it is in the best interest of public health, safety, and general welfare of the community to regulate minimum lot size in the Town to further the orderly layout and land use, prevent overcrowding of land and avoid the undue concentration of population.

**AUTHORITY:** Pursuant to Sec. 60.10 WI Stats. the Town has been granted Village Powers and pursuant to Sec.236.45 has the authority regulate land division.

**DEFINITIONS:**

1. Land Division – means the act of creating a lot, parcel, condominium unit or subdivision of 10 acres or less. The term does not include the divisions which are exempted by Wisconsin law from plat review, which are:
  - a) Transfers of interest in land by will or pursuant to court order.
  - b) Leases for a term not to exceed 10 years, mortgages or easements.
  - c) The sale or exchange of parcels of land between owners of adjoining property if additional lots are not created and lots resulting are not reduced below the minimum sizes required by this ordinance or other applicable laws or ordinances.
2. Formally submitted – means that a proposal was embodied in an application for approval of a certified survey map or subdivision plat which had been filed with Oconto County and the Town of Townsend.

**MINIMUM RESIDENTIAL LOT SPECIFICATIONS AROUND LAKES 30**  
**ACRES OR LESS:**

**MINIMUM LOT SIZE: 2 acres (87120 sq. feet)**

**MINIMUM WIDTH AT THE ROAD: 100 feet**

**MINIMUM WIDTH AT THE ORDINARY HIGH WATER MARK: 200 feet**

**PERMANENT BUILDING CONSTRUCTION MINIMUM DISTANCE TO THE  
ORDINARY HIGH WATER MARK: 125 feet.**

**VARIANCES:**

When the Town Board finds that "extraordinary hardship" or "practical difficulties" may result from strict compliance with and/or the purposes of this ordinance may be serviced to a greater extent by an alternative proposal, it may approve variances. Variances shall not have the effect of nullifying the intent and purpose of land division regulation. Further provided that the Board shall not approve the variances unless it shall make the findings based upon evidence presented to it at a public hearing in each specific case that:

1. The creating of the variance will not be detrimental to the public safety, health, or welfare, or injurious to other properties.
2. The conditions upon which the request is based are unique to the property for which the variance is sought and are not applicable generally to other properties.
3. Because of the particular surrounding, shape, or topographical condition of the specific property involved, a particular hardship to the owner would result, as distinguished from a mere inconvenience, if the strict letter of this Town of Townsend Land Division Ordinance Regulating Lot Size on small lakes is carried out.


**EFFECTIVE DATE:** This ordinance will take effect immediately upon passage and publication as provided by law.


