**ROAD NAME CHANGE ORDINANCE 1-2003
AN ADDITION TO ORDINANCES 2-98 and 1-2001**

WHEREAS: There are several roads in the Town of Townsend all having the same name and;

WHEREAS: Wisconsin State Statute 81.01 Sub-section 11 state that no Town shall have more than one road with the same name and;

WHEREAS: Oconto County Code of Ordinances No 265, Chapter 4, Section 16-4(a) and Resolution NO. 5-2003, state that every effort should be made to avoid duplicate names in the County and;

WHEREAS: Oconto County is updating the 911 System per Ordinance No.1250-2003 and requires all towns, villages and cities in the County to review all roads for duplicate names and to designate names for all private roads, and;

WHEREAS: The Townsend Board of Supervisors deems it to be in the best interest of property owners in the Town of Townsend to provide more certain directions and easier location for Fire and rescue Vehicles,

NOW THEREFORE BE IT HEREBY ORDAINED: By the Townsend Town Board, Oconto County, Wisconsin, that the following Town and Private roads shall be re-named and named as designated:

MARTY ROAD: located in Section 4 T33N R15E, running northwest off Valley View Road, formerly West Valley View Road.

COUGAR LANE: located in Section 20 T33N R15E, running north off Horn Lake Road, formerly Eagle Lane.

ENGELS LANE: located in Section 18 T33N R15E, running west off Forest Hill Drive, formerly Forest Hill Lane.

STATLER LANE: located in Section 10 T33N R15E, running south off Eldorado Road, formerly Eldorado Lane South.

HARLAN ROAD: located in Section 11 T33N R15E, running north off Hemlock Dam Road, formerly North Hemlock Dam Road.

KRUMPOS ROAD: located in Section 12 T33N R15E, running south off Hemlock Dam Road, formerly South Hemlock Dam Road.

DOWNER TRAIL: located in Section 13 T33N R15E, running north off Gluckie Lake Trail, formerly North Gluckie Lake Trail.

TIMBER EDGE LANE: located in Section 23 T33N R15E, running west off Pickerel Lake Road, formerly Forest Street.

MOONLIGHT BAY ROAD: located in Section 22 T33N R15E, running west and south off Sunset Bay Lane, formerly Sunset Bay Road.

DUTTON LANE (PRIVATE): located in Section 29 T33N R15E running east off Birchwood Lane, formerly an un-named private road off Birchwood Lane.

BLUE HERON LANE: located in Section 26 T33N R15E, running south off Brook Road, formerly South Brook Lane.

SMITTY LANE: located in Section 26 T33N R15E, running north off Brook Road, formerly North Brook Lane.

TURTLE TRAIL: located in Section 34 T33N R15E, running South off Stumpf Lane, formerly North Stumpf Lane.

SOLITUDE LANE: located in Section 32 T33N R15E, running south off Sawyer Lake Road, formerly South Wapota Lane.

LEWIS LANE (PRIVATE): located in Section 32 T33N R15E, running south off Sawyer Lake Road, formerly an un-named private road off Sawyer Lake Road.

KOENIG LANE (PRIVATE): located in Section 31 T33N R15E, running west and south off Sawyer Lake Road, formerly an un-named private road off Sawyer Lake Road.

HUNTERS RUN (PRIVATE): located in Section 3 T32N R15E, running north off East Bass Lake Road, formerly an un-named private road off East Bass Lake Road.

BRONCO LANE (PRIVATE): located in Section 3 T32N R15E, running north off east Bass Lake Road, formerly an un-named private road off East Bass Lake Road.

EDDIE LANE (PRIVATE): located in Section 3 T32N R15E, running north off Archibald Lake Road, formerly an un-named private road off Archibald Lake Road.

OLD CAMP POINT LANE (PRIVATE): located in Section 2 T32N R15E running north off Bells Point Road formerly North Bells Point (Private).

BULLFROG BEND: located in Section 2 T32N R15E, running south off Presbyterian Road, formerly Presbyterian Lane and West Presbyterian Lane.

ORALEA LANE: located in Section 2 T32N R15E, running east off Presbyterian Lane, formerly East Presbyterian Lane.

STONEGATE LANE (PRIVATE): located in Section 1 T32N R15E, running north off Archibald Lake Road, formerly an un-named private road off Archibald Lake Road.

FLOWAGE POINT LANE: located in Section 27 T33N R15E, running west off Townsend Dam Road, formerly McCaslin Landing.

RAINBOW POINT LANE: located in Section 28 T33N R15E running south off Bowman Avenue, formerly Island Street.

BUNTING LANE: located in Section 28 T33N R15E, running south off Horn Lake Road, formerly Horn Lake Lane. ~~off~~

RED FOX LANE: located in Section 14 T33N R15E, running south off Smokey Lake Lane, formerly Smokey Lane.

WHITE OWL LANE (PRIVATE): located in Section 17 T33N R15E, running east off Forest Hill Drive, formerly an un-named private road off Forest Hill Drive.

HARMONY LANE (PRIVATE): located in Section 28 T33N R15E, running north off East Burnt Dam Road, formerly an un-named road off East Burnt Dam Road.

The designated road name shall become effective January 1, 2004.

This ordinance shall become effective upon posting in three places within the Town of Townsend.
